

**SUBJECT: REACH REGULATIONS (REG.CE 1907/2006)**

Starting from June 1<sup>st</sup>, 2007, the REACH Regulations 1907/2006 has come to force concerning the registration, evaluation, authorization and restriction of chemicals.

This kind of regulations are referred mainly to producers and importing companies of substances, but it also contains instructions that involve distributors of substances and downstream users.

**SCAME PARRE S.p.A.** qualifies, up to REACH Regulations, as “downstream user”, especially as “user of substances” and “articles producer”, where “articles” has to be intended as each product, component or semi-finished product.

Herewith to inform that, following REACH regulations:

1. All the articles supplied by SCAME PARRE S.p.A. are not subject to the instructions reported by the REACH Regulations;
2. SCAME PARRE S.p.A. cannot be qualified as producer/importer of substances;
3. SCAME PARRE S.p.A. started all necessary actions to comply with REACH Regulation, particularly:
  - Establish communications channels with the upstream supply chain in order to determine if the substances used will be pre-registered/registered by the related importers and producers; ensure that the specific use made by SCAME PARRE S.p.A. is included in the registration dossier and the exposure scenario (where applicable), and identify possible alternative suppliers with a view to assuring the continuity of supply;
  - Perform research and develop processes and alternative substances should the regulation restrict or forbid the use of certain substances by the market, with a view to guaranteeing the continuity, quality and performance of the products/components supplied to the customers;
  - Evaluate the substances used in the articles supplied to its customers, to identify and inform its customers about the presence, pursuant to art. 33 of the REACH Regulation, of any substances exceeding the allowed concentration (0.1% by weight) that will be classified as SVHC (Substances of Very High Concern. The current candidate list is available at the following link: <https://echa.europa.eu/candidate-list-table>.

SCAME PARRE S.p.A. is not obliged to register the chemical substances, from which products are made. This obligation is fulfilled by our suppliers or their upstream suppliers, respectively.

SVHC-information has to be given, if the substance exceeds the mass fraction value of 0.1 and is present in an article as such (the smallest modular unit, that is defined as an article according to REACH Regulation) that is used in SCAME PARRE S.p.A. products.

SCAME PARRE S.p.A products contain many articles as such. In some of those articles, SVHCs are present. Due to the presence of different SVHCs in different amounts as well as in different articles as such, a general statement cannot be made. Hence, the relevant SVHC-information will be shared upon specific request for each individual product.

This declaration is issued based on the information that SCAME PARRE S.p.A. was able to receipt from the supply chain.
