

## Declaration of Conformity to Directive 2011/65/EU (RoHS2) and EU Delegated Directive 2015/863 (RoHS3)

In compliance with Directive 2011/65/EU, which restricts the use of certain hazardous substances in electrical and electronic equipment (RoHS2), and the subsequent EU Delegated Directive 2015/863 (RoHS3), SCAME PARRE S.p.A., with registered office in Via Costa Erta, 15 – 24020 Parre (BG) declares that

- all electrical and electronic equipment produced by SCAME PARRE S.p.A. complies with the RoHS2 and RoHS3 regulations;
- the components supplied by SCAME PARRE S.p.A. are designed to guarantee the RoHS conformity of the finished products in which they will be incorporated, respecting the principle of induced conformity.

### Regulated Substances and Concentration Limits:

In accordance with the RoHS2 and RoHS3 regulations, SCAME PARRE S.p.A. guarantees that the following concentration limits by weight in homogeneous materials are not exceeded:

- Lead and its compounds: max 0.1%
- Mercury and its compounds: max 0.1%
- Cadmium and its compounds: max 0.01%
- Hexavalent chromium and its compounds: max 0.1%
- Polybrominated biphenyls (PBB): max 0.1%
- Polybrominated diphenyl ethers (PBDE): max 0.1%
- Bis (2-ethylhexyl) phthalate (DEHP): max 0.1%
- Benzyl butyl phthalate (BBP): max 0.1%
- Dibutyl phthalate (DBP): max 0.1%
- Diisobutyl phthalate (DIBP): max 0.1%

where “homogeneous material” means a material with a uniform composition or consisting of a combination of several materials that cannot be separated by mechanical actions such as unscrewing, cutting, crushing or smoothing.

The copper alloy contacts used in SCAME PARRE S.p.A. products have a lead concentration of less than 4%, as permitted by exemption 6c of Annex III of the RoHS Directive, which allows the use of lead up to 4% in copper alloys. SCAME PARRE S.p.A. undertakes to periodically monitor the validity of this exemption to ensure continued regulatory compliance.

SCAME PARRE S.p.A. maintains active measures to ensure the continuity and compliance of the supply chain, including:

- constant updating of information based on regulatory developments of the RoHS Directive;
- search for alternative suppliers to ensure continuity of supply;
- development of alternative substances and processes to ensure the quality and performance of the products supplied.

This declaration will be subject to review following relevant regulatory changes, to ensure our customers continue to comply with current regulations.
